Conclusions of Law

1. Pursuant to ' 167.171, RSMo., the superintendent may suspend a student for not more than 180 school days.
2. Pursuant to ' 160.261, RSMo., the district shall suspend the student for not less than one (1) year or expulsion for possession of a weapon except that such suspension may be modified by the superintendent.
3. Pursuant to ' 167.161, RSMo., the School Board of any district may suspend or expel any student:
 - < For conduct which is prejudicial to good order or discipline which tends to impair the morale or good conduct of other students;
 - < Upon finding that the student has been charged, convicted or pled guilty in a court of general jurisdiction for the commission of a felony criminal violation of state or federal law;
 - < For possession of a weapon as defined by 18 U.S.C. ' 921 and those defined in ' 571.010, RSMo.
